TERMS OF USE

These Terms of Use (“**Terms**”) are entered into between Base5 Genomics, Inc., a Delaware corporation, located at 319 N Bernardo Ave, Mountain View, CA, 94043 USA (“**Base5**”, “**we**”, “**us**”, or “**our**”) and you, whether personally or on behalf of an entity (“**you**” or “**your**”) and the Terms constitute a legally binding agreement concerning your access to and use of our software, together with any applicable documentation thereto, and, as applicable, source code, and programming and user interfaces (collectively, the “**Licensed Product**”) as of the first date of your access or use of the Licensed Product.

YOU AGREE THAT BY ACCESSING THE LICENSED PRODUCT, YOU HAVE READ, UNDERSTOOD, AND AGREE TO BE BOUND BY ALL OF THESE TERMS. IF YOU DO NOT AGREE WITH ALL OF THESE TERMS, THEN YOU ARE EXPRESSLY PROHIBITED FROM USING THE LICENSED PRODUCT AND YOU MUST DISCONTINUE USE IMMEDIATELY.

1. License.

- 1.1. **Limited License.** In accordance with the terms and conditions of these Terms, we grant you the nonexclusive license to use the Licensed Product in the United States for internal research and development purposes only.
- 1.2. **Ownership.** All rights to and in the Licensed Product, including, but not limited to, copyrights and trade secret rights, belong to Base5 and Base5 holds title to each copy of the Licensed Product. You are not permitted to transfer or distribute the Licensed Product to others, and these Terms automatically terminate in the event of such a prohibited transfer or distribution. You may make copies of the Licensed Product for your internal research and development purposes and not for commercial purposes as long as these Terms and all copyright and other notices are reproduced and included on all such copies.

2. **Third Party Dependencies.** In connection with your access and use of the Licensed Product, Base5 may include as a courtesy to you certain third-party software dependencies such as tools, drivers and APIs for your use in connection with the Licensed Product (“**Third-Party Software**”). Licensors of such Third-Party Software may limit their liability and may operate under terms and conditions further defining their rights and obligations, including copyrights and notice requirements. You must comply with all such third-party license terms and notices related to such Third-Party Software, as applicable. You will indemnify us for any third-party claims or damages related to your breach of any such third-party license terms.

3. **Term.** These Terms are effective until terminated. You may terminate these Terms by destroying the Licensed Product and all copies thereof. Base5 may terminate these Terms upon notice if you breach any of the terms and conditions contained herein. Upon termination of these Terms for any reason, you must destroy all copies of the Licensed Product in your possession and control. All provisions of these Terms relating to disclaimers of warranties, limitation of liability, remedies, or damages, and Base5’s proprietary rights survive termination.

4. No Warranty.

- 4.1. **No Warranty.** Base5 does not warrant that the functions contained in the Licensed Product will meet your requirements or that the operation of the Licensed Product will be uninterrupted or error free. Any other software furnished with or accompanying the Licensed Product is not warranted by Base5, except as otherwise agreed to by Base5 in a signed writing between you and Base5.
